Notice of Extraordinary Shareholders Meeting and Election of Three New Directors

Polaris Holdings Co., Ltd. (hereinafter "Polaris" or the "Company") announced today that the Company resolved to hold an extraordinary shareholders meeting (hereinafter the "Extraordinary Shareholders Meeting") on December 12th, 2024, as stated in the releases dated October 15th, 2024, titled "Polaris to Drastically Expand Operational Platform through Share Exchange and Wholly-owned Subsidiarization of Minacia with Changes of Shareholder and subsidiaries, etc.", "Notice of Reduction of Capital and Capital Reserve" and "Notice Regarding the Establishment of a Record Date for the Convocation of an Extraordinary General Meeting of Shareholders". In addition, Polaris resolved to submit a proposal to elect three directors (excluding directors who are members of the Audit and Supervisory Committee) to the Extraordinary Shareholders Meeting.

In the management integration with Minacia Co., Ltd. (hereinafter "Minacia") which will become a wholly owned subsidiary of the Company through the share exchange that will take effect on December 27th, 2024, on the assumption that Polaris will obtain approval at the Extraordinary Shareholders Meeting, in order to swiftly realize synergies between both companies resulting from the management integration, Polaris will nominate two current directors of Minacia and one who is mainly in charge of the integration process (PMI: Post-Merger Integration) who are highly specialized professionals as candidates for Polaris's directors, and Polaris will strive to maximize shareholder value through unified management and the smooth execution of the integration process.
